3) SALES AGREEMENT

- This puppy is purebred and is registerable with Full Registration through the American Kennel Club. Full Registration allows breeding and registering offspring as well as being eligible to show in the breed ring.
- This agreement covers a breeding/show puppy and is defined as a Golden Retriever puppy which embodies the characteristics of the Golden Retriever breed.
- This puppy is guaranteed to be healthy at the time of sale.
- The Breeder does not assume any liability for any injury to the puppy after the Buyer takes possession of the puppy.
- The Buyer agrees to have this puppy examined by a veterinarian with 5 business days of taking possession to assure the Buyer that the puppy is healthy. If the puppy is found to be other than healthy (excluding worms, coccidia, giardia or any other parasites common in puppies) at said veterinary visit, the puppy shall be returned to the Breeder immediately and the purchase price will be refunded. Written confirmation of health concern from the veterinarian is required.

- Temperament, breedability and conformation of the Puppy are NOT guaranteed.
- The Buyer agrees to maintain the puppy's health in good condition, feed a high quality food, maintain good weight control and to provide yearly health examinations, vaccinations/titers, heartworm tests and any other usual procedures necessary to assure good health.
- Puppy has had appropriate vaccinations for its age and a record of vaccinations, dewormings and microchip information is supplied to the Buyer.
- The Buyer agrees that this puppy will not be sold or ownership transferred without the Breeder's knowledge and consent.
- The Buyers agrees that if at any time proper care cannot be given to the puppy, the Buyer must contact the Breeder. Breeder will have the option to either take the puppy back or assist the Buyer in placing the puppy in a suitable home.

4) BREEDING REQUIREMENTS

- The Buyer agrees that this puppy will not be bred until it reaches two (2) years of age and has passed the following health clearances.
 - OFA Hips (Excellent, Good or Fair)
 - OFA Elbows (Normal)
 - OFA Cardiac (Normal)
 - OFA Eyes (Normal)
- The Buyer agrees that this puppy will only be bred to other purebred Golden Retrievers.
- The Buyer agrees that any progeny resulting from breeding this puppy will not be sold to brokers, pet stores and/or puppy mills.

5) AKC REGISTRATION INFORMATION

- The Buyer agree to use the kennel name GSR's at the beginning of the puppy's AKC Registered Name. No exceptions will be made.
- Buyer will be given the application for AKC registration at the time that possession is taken.

4) WARRANTY

- Every reasonable precaution has been taken to prevent this puppy from acquiring hereditary diseases.
- Should this puppy develop any of the following issues deemed hereditary by 24 months of age, Breeder will take the puppy back and replace it with a puppy of equal value as soon as available. Costs to return puppy and acquire replacement puppy are at the Buyer's expense.
 - Hip Dysplasia (Mild, Moderate or Severe)
 - Elbow Dysplasia
 - Sub-aortic Stenosis
 - Cataracts

5) TERMS AND CONDITIONS OF WARRANTY

- Eye exams must be performed by a Board Certified Veterinary Ophthalmologist and documents must be supplied to Breeder.
- Sub-aortic Stenosis must be confirmed by Echocardiography and Doppler and performed by a Board Certified Veterinary Cardiologist and documents must be supplied to Breeder.
- Hip and/or Elbow Radiographs must be submitted to and examined by the Orthopedic Foundation For Animals and results must be supplied to Breeder.
- Environmental factors, like high caloric diet during the rapid growth phase, may exacerbate changes in dysplastic hips or elbows. Therefore the Breeder refuses to take responsibility for dysplasia in an overweight puppy and thus Buyer will not qualify for a replacement puppy. Veterinarian records must be made available to prove good weight control.
- No replacement will be given if the puppy has not been examined by 24 months of age.
- Warranty is NULL AND VOID if the puppy has been bred or this contract has not been followed.
- Any breach of these contract terms are subject to a \$5000 penalty and mandatory return of the puppy.

This document represents the entire agreement between the Breeder and the Buyer. No other promises or guarantees are made. The conditions of this agreement may only be changed in writing by mutual consent of both parties.

This document shall be enforced only in the State of Ohio, where the transaction has officially taken place.

THE BUYER HAS READ AND UNDERSTANDS THE FULL REGISTRATION SALES AGREEMENT IN ITS ENTIRETY AND AGREES THAT ALL PARTS AND PORTIONS THEREOF CONSTITUTE A BINDING AGREEMENT. FURTHER, SIGNATURES BELOW ACKNOWLEDGE AGREEMENT AND RECEIPT OF THIS AGREEMENT BY BOTH PARTIES.
